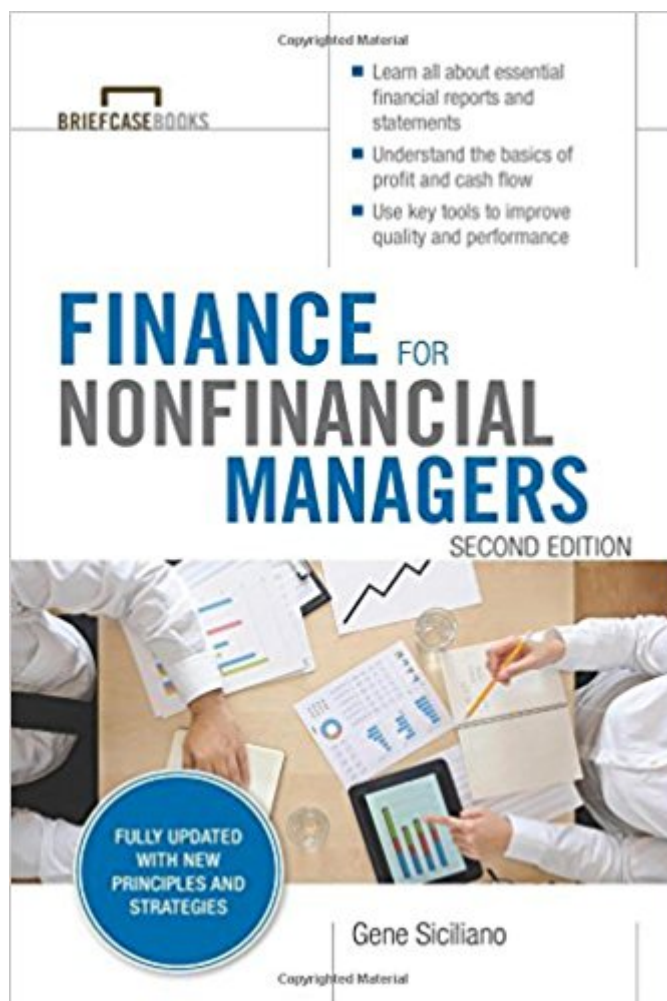

You might know that the balance sheet contains both assets and liabilities? But at the bottom of the assets is a catchall category called, "cleverly", Other Assets! In another section, in Chapter 12, The Annual Budget, he titled "Tools for Telling the Future: Budgets, Forecasts, Projections, and Tea Leaves"!
