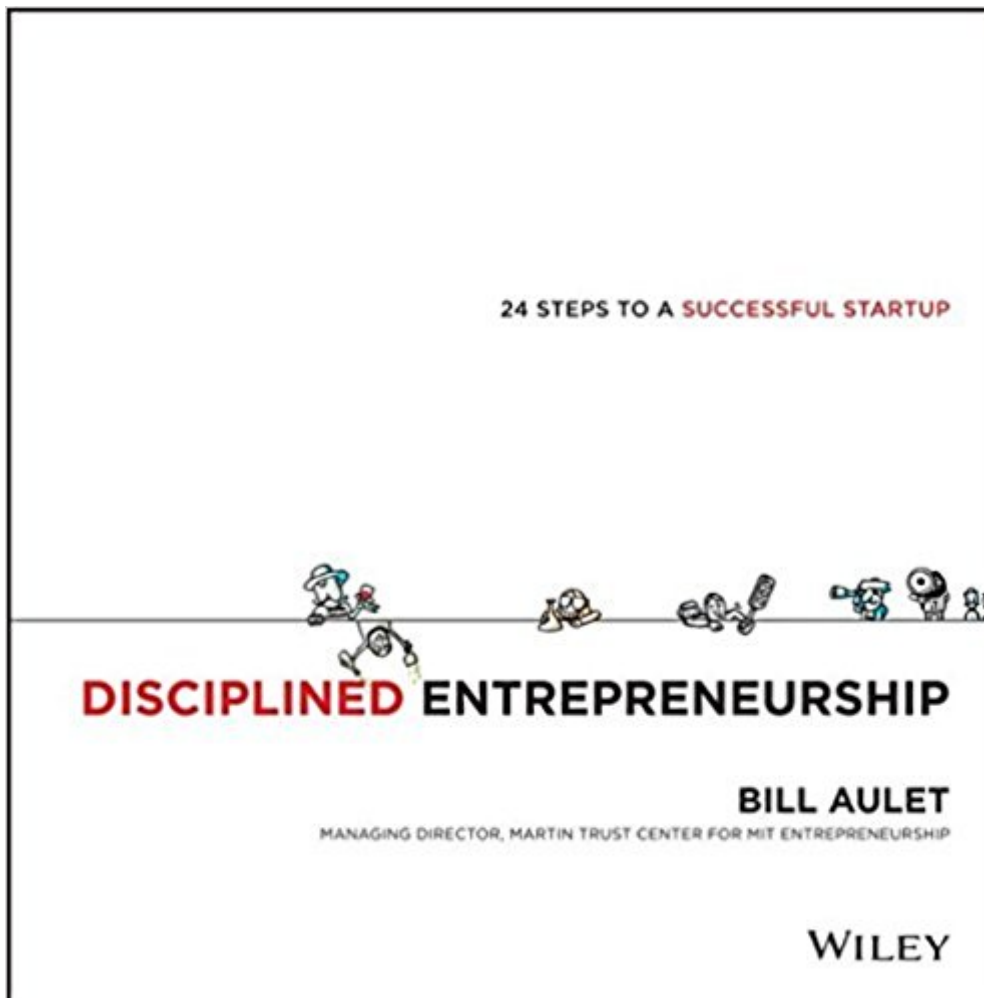

The press is now calling it the "Series A Crunch".
